



What is covered?

This unit describes the performance outcomes, skills and knowledge required to use a knowledge and understanding of skin structure, functions, systems and their interrelationships in order to identify and analyse client needs, design and perform beauty therapy treatments and provide post-treatment service. It requires the ability to use an understanding of skin and hair anatomy and physiology to select the best treatment routine and products and promote skin health and appearance to clients.

This unit applies to beauty therapists who work in beauty salons and spas. In this environment they work as part of a team but make independent treatment decisions.

The skills in this unit must be applied in accordance with Commonwealth and State or Territory legislation, Australian standards and industry codes of practice.
